

# For User Group Gatherings and Events Conducted at a Township of Langley Facility

The Organizer has entered into a Facility Rental Agreement with the Township of Langley. As part of the agreement for use of a Township facility, the Organizer must agree to collect attendee contact information and attendees ("Facility Users") must agree to provide such in order to participate.

By Order of the Provincial Health Officer (updated August 7, 2020), Organizers of permitted Gatherings and Events are required to collect the contact information of all persons who attend their event. (4b.) Where the Organizer is not the owner or operator of the place, the Organizer must provide the owner or operator (Township of Langley) with the first and last names and telephone number, or email address, of the patrons who attend the event. This list will be retained for thirty (30) days in case there is a need for contact tracing on the part of the medical health officer, in which case the information must be provided to the regional medical health officer.

The Organizer is responsible to inform, and receive consent from, all Facility Users attending the event that they must list their full contact information on this Facility User Register, and also consent that their personal information is being collected and provided to the Township of Langley, where it will be retained for a period of thirty (30) days and may be provided to the medical health officer for contact tracing purposes. The information collected will be used for no other purpose.
